Principal Govt Hr. Sec. School Bhalwal (Departmental Representative)

The departmental representative shall work as Nodal Officer of the department who will monitor the implementation of departmental instructions issued from time to time and shall:-

- Maintain close co-ordination with the school management and the department;
- Convene/ attend monthly meetings of the school management and furnish details of the functioning of the school;
- Ensure that the functioning of the school is in accordance with the rules governing them and shall update the department about any contravention/ violation in this regard.

The Management Committee shall perform inter-alia the following duties/ functions:-

- Monitor the working of the School on monthly basis and management shall furnish report to CEO concerned on quarterly basis.
- The Committee shall be responsible for the Management of the School in accordance with the provisions of the act.
- The Management Committee shall remain co-terminus with the permission accorded by the Competent Authority for three years only.
- The management of the school shall consult the Parents' Association in matters of academic importance and co-curricular activities.
- The Managing Committee shall apprise the Parents' Association about the performance and various activities of the school.
- The management of the school shall take the Parents' Association into confidence while taking important decisions affecting the students.
- This order is issued subject to the outcome of the case, if any, pending before the Competent Court of Law.
